 - UOB Credit Cards issued in Singapore, Malaysia, Thailand, or Indonesia (including TMRW Credit Cards issued in Thailand or Indonesia);
 - UOB Debit Cards issued in Singapore, Malaysia or Thailand (including TMRW Debit Cards issued in Thailand);
 - o Citi-branded Credit Cards issued in Malaysia, Thailand or Vietnam;
 - o Citi-branded Debit Cards issued in Malaysia, Thailand or Vietnam.

 Presale. UOB does not control the ticket inventory and does not guarantee ticket
 availability. Tickets will be sold on a first-come, first-served basis while supplies last.
 UOB shall not be required to notify and/or update on the availability or the inventory of
 the tickets reserved for UOB Presale.
- Tickets for the Event must be purchased at www.ticketmaster.sg. The tickets are subject to Ticketmaster's terms and conditions and policies (including but not limited to its admission policies, exchange and refund policies, and restriction/prohibition on re-selling) including but not limited to the following key terms ("Ticket Key Terms"):

Admission requirements/policy

- When arriving in groups, the lead booker who booked the tickets needs to be present in order for the whole party to enter the Event venue. All members of the party should enter the Event venue at the same time. In order for tickets to be valid, on arrival at the Event, the lead booker may be asked to provide all of the following items alongside their ticket(s):
 - i) Photo ID (Driving licence, passport)
 - ii) Booking confirmation email

NOTE: The lead booker/purchaser name will be reflected on the ticket, and the name should match the ID that will be presented upon entry to the Event venue.





Admission to the Event is at all times subject to the terms and conditions of the Event promoter and Event venue operator. Failure to comply with any Event promoter or Event venue terms and conditions may result in refusal of admission or request to leave the Event venue without any refund. Only tickets purchased through approved ticket agents are valid for admission. The Event venue reserves the right to refuse admission.

Prohibition against re-selling

Your ticket(s) including your related account(s) with Ticketmaster will IMMEDIATELY BECOME INVALID if resold OR OFFERED FOR SALE unless the sale of the tickets is through the official ticket agent fan-to-fan exchange. Tickets sold via unauthorized outlets, including online auction sites, and/or in connection with fraudulent activities are not valid for admission. The resale of a ticket renders it invalid and may lead to refusal of entry.

Limit on tickets

 Maximum of 6 tickets per transaction, with no limit on the number of transactions per Ticketmaster account. Every Ticketmaster account can hold more than 6 tickets, with no limit on the number of tickets held per account.
